Research ethics event in European Parliament: TRUST project

The final event of the [TRUST project](#) on double standards, the export of non-ethical research practices to low- and middle-income countries and equity in international research, has taken place in the European Parliament, Brussels, on 29 June 2018.

The event in the European Parliament "Ethics Dumping - Looking for Justice" was co-hosted by TRUST and the European parliamentary group [GUE/NGL](#). Among the speakers were Prof. Jeffrey Sachs (keynote), Irina Bokova (former Director of UNESCO), Prof. Doris Schroeder, Dr François Bompard (formerly Sanofi/EFPIA, currently DNDi) and from EDCTP, Dr Michael Makanga and Dr Leonardo Simão (EDCTP High Representative for Africa). Final speaker was Wolfgang Bartscher (Deputy Director General) who represented Jean-Eric Paquet, Director-General of the DG Research and Innovation, European Commission.

Assessing National Health Research Systems in Africa

EDCTP will work closely with African government entities and the WHO Regional Office for Africa (WHO AFRO) to develop a conceptual framework for the development and strengthening of national health research systems (NHRS) in sub-Saharan Africa.

The [Ghana Health Service](#) of the Ministry of Health Ghana, will host a kick-off meeting for policymakers and health professionals from African countries that are members of the EDCTP Association. The delegates, including strategic partners in the African Union and regional economic communities, will meet in Accra, Ghana from 9-10 July as a first step towards developing the framework.

A main objective of the meeting is to prepare surveys to assess the national health research capacities in the 17 African EDCTP member countries. Government institutions will conduct this assessment through implementation of the NHRS barometer, an assessment tool developed by WHO AFRO. Thirty-four health professionals are expected to be prepared to complete NHRS assessment surveys in the African EDCTP member countries.

Looking ahead: A new EU innovation strategy

On 05 June 2018, the 2018 [Science|Business framework conference](#) took place in Brussels, Belgium. The aim of the conference was to debate the policies and programmes Europe will need for a prosperous future, including an important engine for future growth: research and innovation.

Main topics in the plenary sessions were research and innovation in the new European Union budget, mechanisms for financing innovation, and how Horizon Europe clusters can support achieving the United Nation's sustainable development goals.

With financing research and innovation as central topics, the conference was attended by the Commissioner responsible for the EU budget, Günther Oettinger and Werner Hoyer, the President of the European Investment Bank. Other speakers included Christian Ehler, three-term MEP who is a member of the crucial European Parliament's Committee for Industry, Energy and Research; Prof. Mariana Mazzucato (University College London, UK), who is the special advisor on mission-driven science and innovation to Carlos Moedas, Commissioner for Research and Innovation, European Commission; Jean-Eric Paquet, Director-General of the DG Research and Innovation, European Commission; and Phil Mjwara, the Director General of the South African Department of Science and Technology.

Dr Michael Makanga, EDCTP Executive Director, was one of the panel speakers for the workshop 'Open to the world? How to make Horizon Europe more international?' .



Furthermore he was part of the panel in the afternoon session on 'What's our mission? What goals should we set for the next Framework Programme? Other speakers were: Prof. Mariana Mazzucato, Christian Ehler, Ilkka Niemelä, President of Aalto University (Finland) and Dr Heinz Seyringer, (CEO of V-Research, Austria). Projects

PREV_PKDL consortium | Kick-off meeting | 6-7 June 2018

The PREV-PKDL consortium which prepares clinical trials of a candidate vaccine to prevent chronic dermal leishmaniasis in patients treated for visceral leishmaniasis, held its kick-off meeting in York (UK) on 6-7 June 2018. The EDCTP Project Officer for the project, Dr Michelle Helinski, participated in the meeting.

The promising vaccine has been developed by Prof. Paul Kaye and his team at the University of York, United Kingdom. EDCTP invested EUR 8 million in the project (2018-2023) to prevent post kala azar dermal leishmaniasis (PKDL). The project is coordinated by Dr Odile Leroy, Executive Director of the European Vaccine Initiative (Germany).

EXIT-TB | Translating research into policy for TB screening | 4-5 July 2018

EXIT-TB, the large project to study how to scale up "evidence-based multiple focus integrated intensified TB screening to end TB in the East African Region" will have its consortium kick-off meeting in Arusha, Tanzania, on 4 and 5 July 2018. The project is coordinated by Dr Esther Ngadaya of the National Institute for Medical Research of Tanzania. EDCTP Project-Officer, Michelle Nderu will contribute to the meeting.

EDCTP invested almost EUR 3 million in the project which receives an equal amount of African and European co-funding from: the University of Addis Ababa (Ethiopia), the Centre for Global Health Research - KEMRI (Kenya), the University of Bergen (Norway), the Institute of Endemic Diseases - University of Khartoum (Sudan), the Kilimanjaro Clinical Research Institute (Tanzania), the National Institute for Medical Research (Tanzania), and the Infectious Diseases Institute - Makerere University (Uganda).

The European Open Science Cloud summit 2018 took place with the support of the EOSC High Level Expert Group and of the FAIR Data Expert Group, that are both advising the Commission on the way forward with the implementation of the European Open Science Cloud (EOSC).

Neglected Infectious Diseases | ISNTD d3 2018 | London, UK, 25-26 June 2018

The International Society for Neglected Tropical Diseases organised its 2018 d3 conference on Drug discovery & development, diagnostics and vaccines for tropical diseases in London on 25 and 26 June. The programme focused on recent developments, gaps and future needs of paediatric drug discovery, treatments and diagnostics (day 1: drug discovery & development, vaccines & synthetic biology; day 2: diagnostics beyond diagnosis, i.e. evaluation, surveillance & monitoring).

Dr Magda Moutaftsi, EDCTP Strategic Partnerships Officer, was invited to open the first day with an introduction of EDCTP as a 'a funding mechanism for the development of medicinal products for Sub-Saharan Africa'.

EDCTP2 funded already six projects for NTDs with a total value of €23.4 million. Large projects have been funded in four diseases - human African trypanosomiasis, schistosomiasis, cysticercosis/taeniasis and leishmaniasis - while fellowships have been awarded for research projects on schistosomiasis, Buruli ulcer, leishmaniasis and lymphatic filariasis. Two calls for

proposals were launched in 2017 that will expand the neglected infectious diseases portfolio: at least six more projects will be funded in 2018 with an estimated value of €22.7 million.
