

# 2019 Annual Report of the EDCTP Scientific Advisory Committee

# 1 Introduction

The General Assembly (GA) established the Scientific Advisory Committee (SAC) to act as the principal advisory group to EDCTP. The SAC provides scientific and strategic advice to the GA and the Secretariat (SEC), overseeing the scientific integrity of the EDCTP programme.

Specific responsibilities of the SAC include:

#### Strategic planning

- Assist in the designing of the scientific and strategic framework of the EDCTP programme
- Advise on the development of the EDCTP operational plan and annual workplans for approval by the GA
- Advise on strategies to foster synergies and partnerships with stakeholders in the North and South
- Contribute to the preparation of scientific and strategic documents relevant to EDCTP, as required
- Provide scientific and strategic advice to the GA and the SEC to ensure the successful completion of on-going projects
- Identify strategic research needs and priorities for accelerating the development of new or improved clinical interventions, including the required training, networking, and capacity building to be undertaken to achieve these objectives
- Review the landscape of Poverty-Related and Neglected Diseases (PRNDs) to identify the role that EDCTP should play in partnership with other stakeholders to accelerate the development or improvement of interventions against these diseases
- Assess the state of global product development pathways and the critical path opportunities for future product development
- Provide advice on the launch and review of any calls for proposals and other programmes.

## Reporting and Monitoring & Evaluation

- Support and provide input to the monitoring and evaluation framework of the EDCTP programme
- Provide input to the monitoring of scientific outcomes and strategic impacts of EDCTP-funded grants and programs
- The SAC Chairperson shall prepare an annual report on the previous year's SAC activities and achievements for submission to the GA by 31 January of each year. The report shall include a summary detailing the strategic and scientific advice provided to the SEC, GA, and Board throughout the year.

## Advocacy and representation at meetings and events

- Participate in EDCTP working groups, stakeholder meetings, and the EDCTP Forum
- Advise and assist in the organisation of workshops, meetings, and other relevant events.

# 2.1 New SAC membership for 2019-2021

Seven SAC membership appointments terminated on 31 December 2018. In December 2018 the EDCTP Board approved seven new members and five reserve members to join the SAC. This decision was presented to the General Assembly (GA) for their endorsement. On 21 January 2019 the GA approved the appointment of the recommended new members and reserve members of SAC, to serve effective from January 2019.

## 2.2 SAC meetings

SAC members attended two official meetings in 2019. The first meeting was held in The Hague, The Netherlands on 21 May 2019 in conjunction with the Joint GA/SAC meeting of 22 May 2019. The second was held on 18-19 September 2019 in Liverpool, UK. Observers from the European Commission (EC), the WHO Regional Office of Africa (WHO-AFRO), and WHO Geneva were also in attendance.

The SAC Chair attended the GA meetings held in May and November 2019 at which she provided an update to GA members on SAC activities. During the September SAC meeting, the Chair updated SAC members on the outcomes of the May GA meeting.

## 2.3 Strategic planning

During both SAC meetings, members were updated with the progress of the 2019 EDCTP work plan, including the analysis of calls for proposals launched to date.

SAC provided input into the draft 2020 EDCTP work plan, taking into consideration that 2020 would be the last year in EDCTP2 for launching 4-year research and innovation actions (RIA) and senior fellowships. The remaining years of EDCTP2 would be devoted to short fellowships and promising activities such as proof-of-concept studies and knowledge translation activities to inform strategic planning for the EU-Africa GHP draft plan.

SAC also provided an update to the Strategic Research Agenda (SRA). This document is updated annually and provides the basis for the SEC to propose the annual work programme of the following year to the General Assembly for approval. The SRA outlines the key research and capacity gaps for diseases within the EDCTP scope and ranks them in terms of priorities.

# 2.4 Monitoring & Evaluation

The SAC tracked progress by the SEC in implementing the framework on results-based monitoring and evaluation that had been recommended by the interim evaluation of the EDCTP2 program.

## 2.5 Advocacy and representation at meetings and events

- SAC members provided the SEC feedback on the programme of the Tenth EDCTP Forum, which is scheduled to take place in Q4 of 2020. The SAC Chair was named co-chair of the EDCTP Forum Committee for 2020.
