### Data sharing: how to make it feasible, easy and accessible

The *BMJ Global Health* published a Commentary piece on data sharing, written by staff of the Centre for Tropical Medicine and Global Health, University of Oxford (United Kingdom) and EDCTP (The Hague, the Netherlands):

Gabriela Karolina Hajduk, Nina E Jamieson, Bonny L Baker, Ole F Olesen, Trudie Lang: 'It is not enough that we require data to be shared; we have to make sharing easy, feasible and accessible too!' [BMJ Global Health Journal July 2019](#). Dr Ole Olesen is EDCTP Director of International Cooperation Europe and Prof. Trudy Lang ([The Global Health Network](#)) is the corresponding author.

The item reflects the work done to create the EDCTP Knowledge Hub on data sharing, a project funded by EDCTP. The 'hub' is developed in collaboration with The Global Health

Network. With the support of the European Union, EDCTP aims to facilitate the sharing of data resulting from the clinical research it funds.

As the Commentary explains, it is not enough to just require grantees to share data. Currently, there are "no clear standards and guidelines of how, where and when researchers should share their data". This has led to initiatives by funders "to provide their grantees, and the wider scientific community within the field of global health research, with clear guidance and a range of tools to facilitate the data sharing process".

EDCTP is working in collaboration with The Global Health Network "to assess whether a cross-cutting knowledge hub around data sharing would help researchers find the optimum repository and to gather their data in a form that is ready for sharing." A first version of the 'knowledge hub' was shared and discussed with an audience of researchers at the Ninth EDCTP Forum in Lisbon, Portugal, in September 2018.

## CRIGH: Mapping global clinical research support organisations

The Clinical Research Initiative for Global Health (CRIGH) was launched on 01 January 2017 and aims to be "support international collaboration on clinical research for the benefit of patients, healthcare professionals, and health systems".

The initiative seeks to optimise clinical research programmes in participating countries, to develop global standards on clinical research, and to promote the take-up of innovative methodology and technologies. To date, 14 organisations have joined as members; WHO and OECD are observers. Its secretariat is jointly held by ECRIN, the European Clinical Research Infrastructure Network and the National Institutes of Health (USA).

One of the current CRIGH projects is to map clinical research support organisations around the world. To this end, a survey was developed to understand how support services for academic clinical research are organised in various countries and world regions and to identify funding opportunities for multinational studies.

EDCTP invites African stakeholders in clinical research support to join the survey. From the CRIGH project manager: "The mapping of organisations supporting clinical research throughout the African continent is key for future international collaborations. The outcomes of the survey will be made publicly available through a report that will boost the visibility of participating organisations, integrating them into the global landscape of clinical research support, and facilitate the creation of forthcoming consortia. All survey respondents, and their corresponding institutions will be cited in the report. The CRIGH initiative continues to welcome institutions who are interested in joining. ## EDCTP active at 69th Session of WHO Regional Committee for Africa

Dr Leonardo Simão, EDCTP High Representative for Africa and Dr Michael Makanga, EDCTP Executive Director, participated in the 69th session of the Regional Committee (RC69) for Africa held in the WHO Regional Office for Africa in Brazzaville, Congo from 19-23 August 2019. EDCTP is now an officially recognised WHO-AFRO partner with a dedicated observer in the annual regional committee of health ministers meeting.

The event presented EDCTP also with important opportunities for bilateral meetings with several country delegations, in most cases led by their Ministers of Health. Delegations were informed of EDCTP-funded activities in their respective countries and EDCTP's added value for Africa. Scaling up of national investment in health research and related capacity was encouraged. Moreover, efforts were made to reach out to the Portuguese speaking community of states.

Besides participation in the RC69 in Brazzaville, the EDCTP delegation met with Professor Francine Ntoumi, EDCTP coordinator for the Central African EDCTP Network of Excellence CANTAM and the PANDORA-ID NET consortium. Secondly, EDCTP was received by the Minister of Science & Technology, the Hon. Mr Aime Parfait Mavoungou, and senior officials of his ministry. This visit was aired on national Congolese television.

**Wellcome Trust | Impact of Vaccines on AMR | Deadline 06-09-2019**

This scheme supports researchers investigating the impact of vaccines on antibiotic use and/or antimicrobial resistance. The aim is to support and inform vaccine decision-makers around the world and tackle antimicrobial resistance.

The award is open to individuals or teams of up to seven people, from anywhere in the world. Team members can be based in different organisations and countries. Your programme must aim to analyse data on AMR or antibiotic use in the context of a human vaccine study. One can propose to work on vaccines that are marketed or in development.

The vaccines should target pathogens that are becoming more difficult to treat with antibiotics and/or cause symptoms that drive antibiotic use. These may include (but are not limited to) vaccines against: *S. pneumoniae*, *H. influenzae*, *S. Typhi*, Rotavirus, Influenza and Malaria. ### **COR-NTD | African Researchers' Small Grants Program | Deadline 3/09 2019**

Through the Coalition for Operational Research on Neglected Tropical Diseases (COR-NTD), the African Research Network for Neglected Tropical Diseases (ARNTD) with support from the U.S. Agency for International Development (USAID) and UK AID (UK) is seeking proposals for both operational and social science research on "Emerging Challenges facing NTD program implementation in Africa."

This third edition of the Small Grants Program (SGP III) is to support African researchers in both early and mid/late career to undertake operational research aligned with the goals established in the London Declaration on Neglected Tropical Diseases. SGP III is comprised of two small grant funding tracks: a) Small grants for junior researchers, and b) Small grants for mid-career and/or senior researchers.

"Call 10 specifically invites applications for definitive RCTs that provide generalisable data, beyond a single country. The evidence generated should be robust and relevant to international and regional policy makers and directly answer questions to change policy and guidance.

### **VALIDATE Network | Pump-priming grants | Deadline 22/10 2019**

The VALIDATE Network aims to accelerate vaccine research and development for complex intracellular pathogens that cause diseases significant to low and middle-income countries (LMIC), with an initial focus on *Mycobacterium tuberculosis*, *Leishmania spp.*, *Burkholderia pseudomallei* and *Mycobacterium leprae*.

Grants are available for pump-priming projects of up to £50,000 (at 100% FEC), via competitive application to the Network's Management Board. Projects should run for a maximum of 12 months and should lead to relevant and useful data for the field or produce pilot data that will lead to a larger grant application to an external funder. Collaborative projects led by and/or involving LMIC researchers are strongly encouraged to apply.

### **DFID UKAID | Research capacity strengthening | literature review**

The UK Department for International Development commissioned and published an interesting literature study on research capacity strengthening in low- and middle-income countries. The report was produced by Research Consulting

Mattia Fosci, Lucia Loffreda, Lennart Velten, Rob Johnson (2019) '[Research Capacity Strengthening in Low- and Middle-Income Countries: a Rapid Evidence Assessment of the literature on interventions to strengthen research systems and organisations](#)'.

In the conclusion, the authors point to several good practices for research capacity strengthening both at the system level and the institutional level. They also highlight three evidence gaps: 1) "lack of up-to-date baseline data on research systems"; 2) "a lack of evidence about the effectiveness of specific interventions and intervention strategies"; 3) "a limited understanding of strategies that support the use of research in policy making and the economy".
