## EDCTP contributed to World Health Summit 2019

EDCTP contributed to the [World Health Summit programme](#) (Berlin, Germany, 26-29/10 2019) with a workshop on health research capacity development and a panel discussion on medical needs of vulnerable populations - see the next two items. The conference was attended by Dr Michael Makanga (EDCTP Executive Director), Dr Ole Olesen (Director of International Cooperation for Europe) and Administrative Support Officer Nora Bünemann.

The conference offered many opportunities for networking and side meetings as well as the participation offered by the programme. On Tuesday 29 October Dr Michael Makanga attended the DNDi-hosted workshop on 'Co-Creation and Co-Ownership of the UHC and SDG Agendas'. The workshop brainstormed how to ensure neglected populations are at the centre of the implementation of the Universal Health Care effort and the various agendas for achieving the Sustainable Development. Areas of critical importance such as innovation and access need to be designed with and around these populations. Dr Michael Makanga presented EDCTP as an example of a current partnership and described its efforts towards UHC and SDGs.

## WHS2019: workshop on health research capacity building

On 28 October EDCTP, the German Federal Ministry of Education and Research (BMBF) and the Institut Pasteur hosted a [workshop on 'Capacity Building in Health Research in Low-Resource Settings'](#) with a central question of how funders and those implementing the plans may better coordinate capacity building efforts in sub-Saharan Africa. The workshop was chaired by Dr Leonardo Simão, EDCTP High Representative for Africa, and Dr Ole Olesen, EDCTP Director of International Cooperation for Europe.

The session brought together a diverse group of representatives from diverse organisations involved in different aspects of capacity building. Current capacity building initiatives were presented and it was discussed how funders could coordinate and align their efforts among themselves and between funders and implementing countries. The importance of global, national and regional research was highlighted as well as the need to address its long term sustainability.

Prof Imelda Bates provided insights from an academic point of view on how to design, measure and evaluate programmes to strengthen research capacity. Dr Monique Wasunna, Regional Director of DNDi (replacing Dr Kundai Chinyenze) underlined the importance of coordination and collaboration between funders and implementing countries.

The workshop was attended by over 80 participants who engaged in a lively discussion.

## Max Planck Society and EDCTP panel discussion at WHS2019

On 29 October 2019, EDCTP and the [Max Planck Society](#) held a high-level panel discussion on 'Tackling Unmet Medical Needs of Vulnerable and Neglected Populations: Accelerating R&D of Innovative and Effective Medical Interventions through Partnerships and Strategic Alliances'. The discussion was chaired by Prof. Stefan H.E. Kaufmann and Dr Michael Makanga, EDCTP Executive Director.



Speakers at the session were Dr Angela Loyse (St George's University of London), Catherine K. Ohura (GHIT Fund), Peter Sands, (The Global Fund to Fight AIDS, Tuberculosis and Malaria), Dr Soumya Swaminathan (WHO), Prof. Dr Veronika von Messing (BMPF) and Prof. Dr. Gerhard Walzl (Stellenbosch University).

Despite much progress, poverty-related infectious diseases such as tuberculosis, HIV/AIDS, malaria and the neglected and emerging diseases, still impose a high burden on individuals and society. Achieving most if not all Sustainable Development Goals will depend on effective control of infectious diseases.

Peter Sands emphasised the importance of innovative drugs, vaccines and diagnostic tools in tackling poverty-related infectious diseases. Dr Angela Loyse provided insights on the DREAMM (Driving Reduced AIDS-associated Meningo-encephalitis Mortality) project, which is a multi-centre implementation project, evaluating a new semi-quantitative cryptococcal lateral flow assay in three African low- and middle-income countries. Prof. Dr Gerhard Walzl presented the innovative EDCTP-funded project 'TriageTB', which develops and evaluates a point-of-care diagnostic test for active tuberculosis.

In addition to the panel meeting, Dr Catherine Ohura (CEO & Executive Director of the Japanese Global Health Innovative Technology HIT Fund) and Dr Michael Makanga have discussed collaboration on current and future R&D efforts in poverty-related diseases.

## Recent events

### **EDCTP AREF | Grant proposal writing for francophone scientists| 14-16/10 2019**

Together with the Africa Research Excellence Fund (AREF), EDCTP organised a three-day workshop on grant proposal writing for researchers from 13 francophone African countries.

The participants were competitively selected to attend the workshop, which took place in Libreville on 14-16 October, facilitated by a team from AREF. The AREF team comprised Dr Peter Dukes, Dr Bridget Bannerman, Mr Dembo Kanteh and Dr Modibo Sangaré.



The practical and interactive workshop was conducted in English and French and consisted of a combination of plenaries and group work sessions. Topics included English for scientists, development of a research question and proposal, budget planning; mentoring and coaching, and the development of research career plans.

EDCTP was represented by Prof. Ayola Akim Adegnika, the representative for Gabon at the EDCTP General Assembly, Dr Ole Olesen (Director of International Cooperation for Europe), and Mrs Ana Lucia Weinberg (Strategic Partnerships Officer).

### **EDCTP | Information session on EDCTP for researchers in Gabon | 16 /10 2019**

The grant writing workshop in Gabon was followed by an open EDCTP information session for Gabonese researchers on 16 October. The session was co-organised with the Ministry of Higher Education and Research in Gabon and was held at the Faculté de Médecine et des Sciences de la Santé (FMSS) in Libreville.

The aim of the meeting was to present the EDCTP programme and its funding mechanisms and opportunities to local researchers. More than 100 attended. The meeting was chaired by Prof. Akim Ayola Adegnika (CERMEL) and Dr Ole Olesen. Mrs Ana Lucia Weinberg presented funding opportunities and two EDCTP Fellows, Prof. Marielle Bouyou and Prof. Jean Nachege, shared their experiences as EDCTP grantees.

### **EDCTP | Meeting with the Hon. Moukagni-Iwangou | 16/10 2019**

Prior to the information session, an EDCTP delegation led by Dr Ole Olesen was received by the Hon. Moukagni-Iwangou, the Minister of Higher Education, Scientific Research and Technology Transfer of Gabon. The purpose of the meeting was to discuss Gabon's participation in EDCTP and the country's future research priorities. Gabon has been an EDCTP member since 2015.

### Projects

#### **INTENSE-TBM | Project website published | October 2019**

The challenge: "In 2017, an estimated 10 million new cases and 1.6 million deaths occurred worldwide due to tuberculosis [WHO 2018]. The most lethal and disabling form of TB is tuberculous meningitis (TBM), with an estimated 100,000 new cases occurring per year, representing around 6% of extra-pulmonary TB cases.

In sub-Saharan Africa, TBM mortality reaches 40% in HIV-negative patients and up to 70% in HIV-positive individuals with drug resistant *Mycobacterium tuberculosis* strains, with death occurring most frequently within the first 2 weeks after diagnosis. Amongst TBM survivors, 50% are disabled due to neurological sequelae."

INTENSE-TBM is funded by EDCTP, sponsored by Inserm-ANRS, and coordinated by the University of Bordeaux. The project aims to improve the overall care of people affected by tuberculous meningitis. A clinical trial will be conducted in four African countries: Ivory Coast, Madagascar, South Africa and Uganda. It will evaluate the efficacy of an intensified treatment of tuberculosis in patients co-infected or not with HIV.

#### **STATIN TB | Project website published | October 2019**

The StatinTB project (Preventing TB relapse and chronic lung disease: a proof-of-concept, double-blind, randomised, placebo-controlled trial to evaluate the safety and efficacy of statin therapy to reduce inflammation after TB treatment completion in HIV-infected and

HIV-uninfected adults measured by FDG-PET/CT) [published its website](#). The study is coordinated by Dr Reto Guler (University of Cape Town, South Africa),

### **PEOPLE | Leprosy study website published | October 2019**

The EDCTP-funded PEOPLE (Post-Exposure Prophylaxis for Leprosy in the Comoros and Madagascar) study [published its project website](#):

"Within the framework of the PEOPLE project, a large, multi-partner clinical trial, four methods of preventive treatment will be tested to stop the disease in the Comoros and Madagascar, which are the two most affected countries. Nearly 150.000 contacts of leprosy patients to participate are planned to participate in this large-scale study." The study is coordinated by Prof. Bouke de Jong of the Institute of Tropical Medicine in Antwerp, Belgium.

### **EMPIRICAL | Project website published | 01/11 2019**

The EMPIRICAL project (Empirical treatment against cytomegalovirus and tuberculosis in severe pneumonia in HIV-infected infants: a randomised controlled clinical trial) coordinated by Dr Pablo Rojo published [its website](#). The project organised its kick-off meeting in June 2019.

The EMPIRICAL study will be conducted in six sub-Saharan African countries (Ivory Coast, Mozambique, Uganda, Zambia, Zimbabwe and Malawi) to evaluate the safety and efficacy of empirical treatment against cytomegalovirus and tuberculosis in HIV-infected infants aged 1-12 months admitted to hospital with severe pneumonia. Study end-points include 15-day and 12-month survival.

### **SMART | Senior Fellow Dr Faith Osier | October 2019**

EDCTP Senior fellow Prof. Faith Osier (project: SMART - Harnessing parasite diversity and naturally acquired protective immunity against *Plasmodium falciparum* malaria for the development of highly effective vaccines) was elected president of IUIS, the International Union of Immunological Societies as of October 2019. Recently, she was also appointed Ambassador for the UN Sustainable Development Goals 3: Good Health and Well-Being. This last week, she gave a [Spotlight talk at the Grand Challenges](#) meeting in Addis Ababa, Ethiopia.

The Faculty for the Future program, launched in 2004, awards fellowships to women from developing and emerging economies to pursue PhD or Post-doctoral research in science, technology, engineering and mathematics (STEM) at leading universities worldwide. The program's long-term goal is to generate conditions that result in more women pursuing scientific careers by lowering the barriers women face when entering STEM disciplines, thus reducing the gender gap. ### **Wellcome Trust | international Intermediate fellowships | Deadline 21/11 2019**

Who can apply? You can apply for an International Training Fellowship if you're a national of a low- or middle-income country; your proposed research focuses on a health priority in a low- or middle-income country; you have sponsorship from an eligible host organisation in a low- or middle-income country. You can apply if you have a PhD or you're a clinically qualified doctor (and qualified to enter higher specialist training), vet, dentist or clinically qualified psychologist; you have significant research experience; you have made important contributions to your area of research e.g. publications, patents, software development or an impact on health policy or practice.

Level of funding: Salary and research expenses covered. Duration of funding: 5 years. You are a national of a low- or middle-income country; your proposed research focuses on a health priority in a low- or middle-income country; you have sponsorship from an eligible host organisation in a low- or middle-income country. You should be driving your own research and be ready to lead an independent research programme.

You can apply for an International Training Fellowship if you're a national of a low- or middle-income country; your proposed research focuses on a health priority in a low- or middle-income country; you have sponsorship from an eligible host organisation in a low- or middle-income country.

You must have a PhD and be an early-career researcher, or have a degree in a relevant subject and some initial research experience, or be a clinically qualified doctor (and be qualified to enter higher specialist training), vet, dentist or clinical psychologist, and have some initial research experience.

You must want to undertake a guided period of research so that you can consolidate your existing experience and explore new areas of research.
