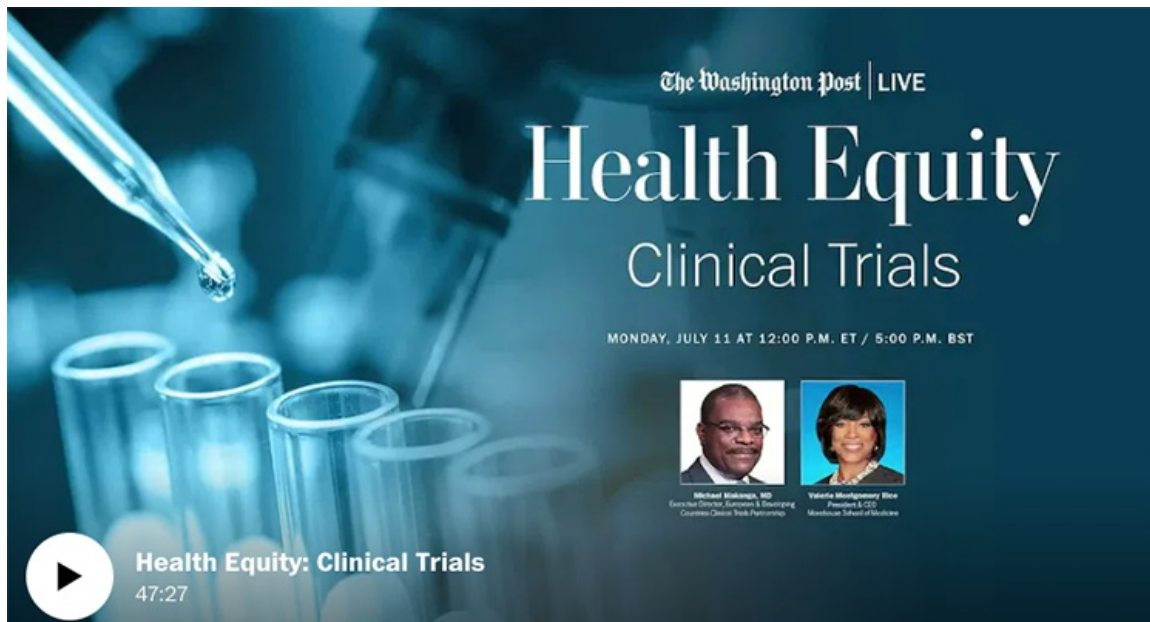

## EDCTP National Health Research Systems 2020 survey report



Recent public health emergencies in Africa have shown that countries with poor health research systems and weak research infrastructure need to be strengthened to meet the challenges of outbreak preparedness. In 2018, EDCTP and the WHO Regional Office for Africa (WHO-AFRO) partnered to explore the use of a 'barometer' as a tool to create a roadmap for the development of national health research systems (NHRS) in the region. EDCTP's latest survey based on this barometer shows a slight overall improvement in the performance of the NHRS of its African Participating States.

On 11 July 2022, Washington Post Live broadcast a live online interview with EDCTP Executive Director Dr Michael Makanga about how to make medical research more representative and the lessons learned from the coronavirus pandemic. The interview was conducted by Frances Stead Sellers, senior writer at The Washington Post. One of the key topics was the question why fewer than 3% of clinical trials take place on the African continent, while the continent carries 25% of the global disease burden.

## Sharing and reuse of health-related data for research purposes: WHO policy and implementation guidance

In April 2022, WHO published a new guide '[Sharing and reuse of health-related data for research purposes: WHO policy and implementation guidance](#)' which outlines WHO's position that sharing research data is a global public good. The policy requires WHO-supported researchers to share data in ways that are equitable, ethical and efficient and follow the technical requirements to ensure the data are findable, accessible, interoperable and reusable – the [FAIR](#) principles – which is in keeping with EDCTP's policy on clinical trials registration, publication and data sharing. WHO's guide also directs researchers to comprehensive resources, including the [EDCTP Knowledge Hub](#), developed in partnership with The Global Health Network. According to the guidance document, the Knowledge Hub *"provides a wealth of good research practice resources, reading material and explanatory videos as well as a search function to identify the best online repository to share your research data."* EDCTP will continue to support researchers to design, conduct and share research of the highest quality and we strongly encourage anyone working in clinical research to visit our Knowledge Hub and make use of these free interactive toolkits and resources.

## WHO report on Accelerating access to genomics for global health



# Accelerating access to genomics for global health



On 12 July 2022, WHO's Science Council of experts published its first report on accelerating access to genomics for global health. The report follows the release of WHO's 10-year strategy for genomic surveillance of pathogens. Genomic surveillance has played a crucial role in the global COVID-19 response, with countries like South Africa able to make crucial contributions in detecting variants, due to their capacities in this area. Recent data from WHO shows that the percentage of countries able to conduct genomic surveillance increased from 54% to 68% between March 2021 and January 2022, due to major investments made during the COVID-19 pandemic.

The report recommends, among others, that WHO create a Genomics Committee. A key responsibility proposed for the Genomics Committee is convening commercial organisations to develop and implement ways of making their products and technologies affordable in LMICs.

The aim of the consultation is to let a wide range of participants, from stakeholders to the public, give their views on what the global health strategy should include. The public consultation is open until 19 September 2022. The input will be summarised in a synopsis report, explaining how it has been taken into account.

## Recent events

### EDCTP visit to Zimbabwe

On 4-5 July 2022, a three-person EDCTP team comprising its Director of Finance &

Administration, Operations Manager and Strategic Partnerships & Capacity Development Manager visited the University of Zimbabwe Clinical Research Center (UZCRC). Nine institutions in Zimbabwe received research funding from EDCTP under its first programme (2003-2015), totaling €3.1 million. Under the second EDCTP programme (2014-2024), seven institutions in the country were awarded a total of €11.7 million, of which €6.1 million is allocated to 13 projects at UZCRC.

The projects include three Coordination and Support Actions (CSA), including one participation in the southern Africa Regional Network of Excellence, one Participating State Initiated Activity (PSIA), seven Research and Innovation Actions (RIA) and one Training and Mobility Action (TMA). These projects are aiming to find key solutions and interventions across different disease areas including improving treatment strategies of adolescents infected with HIV, improving fixed-dose combinations of anti-retroviral treatment among children with new HIV-infection, optimising second-line treatment options for children infected with HIV, and improving survival of HIV-infected children with severe pneumonia. The visit to UZCRC was very successful.

EDCTP routinely visits research centres it funds in sub-Saharan Africa if they meet the eligibility criteria, which includes: centres with actual expenditure exceeding €325,000; projects with many financial reports violating good practices; centres with more than one EDCTP project; previous unfavourable visit reports; centres with high staff turnover in the finance department; and new or private institutions that have never received funding from EDCTP before.

## **Workshop on EDCTP Association Member contributions to Global Health EDCTP3**

On 13 July 2022, the EDCTP Secretariat organised a workshop for EDCTP Association General Assembly Members on how they can make in-kind contributions to additional activities (IKAAs) of the Global Health (GH) EDCTP3 Joint Undertaking (JU). IKAAs are activities that are funded and implemented by one or more EDCTP Association Member participating in the GH EDCTP3 JU and which fall within the scope of the GH EDCTP3 [Strategic Research and Innovation Agenda](#). Planned IKAAs are included as an annex to the annual work programmes of the GH EDCTP3 JU. The workshop, which was attended by over 30 participants, provided an overview of the GH EDCTP3 JU governance and priority areas, and explained in detail the mechanism for IKAAs. Discussion was focused on approaches for identifying and submitting IKAAs (including joint initiatives), strategies for alignment, and potential actions for linking up with the activities funded by other countries. A subsequent workshop focusing on reporting requirements for IKAAs is expected to take place later this year.

## **Project news**

### **EMPIRICAL study: Patient recruitment reaches halfway point**



The EMPIRICAL study (Empirical treatment against cytomegalovirus and tuberculosis in severe pneumonia in HIV-infected infants: a randomized controlled clinical trial) has reached an important milestone: on 8 July 2022, the clinical study randomised patient number 312, which is 50% of the study's recruitment target of 624.

All children have been enrolled in a phase IIb study in The Gambia evaluating the efficacy of a highly promising vaccine against enterotoxigenic *E. coli.*, known as ETVAX®. The **ETEC ETVAX** project is developing a new formulation of ETVAX® that will be better suited to young children, as well as a convenient device for administering the vaccine.

## BREATHER Plus: start of recruitment in Uganda



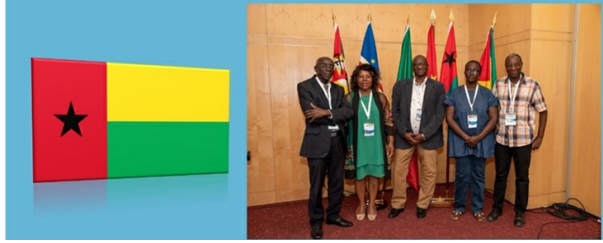

### Global Health EDCTP3 Joint Undertaking calls for proposals | Deadline: 30 August 2022

The Global Health EDCTP3 Joint Undertaking (GH EDCTP3 JU) launched its first [calls for proposals](#) in May 2022 with a deadline of 30 August 2022. The topics of the calls are:

- Promoting implementation of research results into policy and practice
- Creating a sustainable clinical trial network for infectious diseases in sub-Saharan Africa
- Genomic epidemiology for surveillance and control of poverty-related and emerging/re-emerging infections in sub-Saharan Africa
- Strengthening regulatory capacity for supporting conduct of clinical trials
- Implementing adaptive platform trials

### AVAREF Good Clinical Practice (GCP) course

On 26 May 2022, the World Health Organization (WHO) launched a clinical trials inspections online course. One of the most important aspects of a clinical trial is the capacity of the sites and compliance with the approved protocol, hence the importance of good clinical and laboratory practices. This online training is designed to complement the African Vaccine Regulatory Forum (AVAREF) guideline and checklist for the inspection of clinical trials. It is intended for the professional development of good clinical practice (GCP) inspectors through self-paced learning. The course is available in English, French and Portuguese.
